Ms. Ketaki Tribhuwan, Clinical Instructor of our Institute briefed about Samstha, Bharatratna Maharshi Dhondo Keshav Karve, and Ms. Florence Nightingale followed by garlanding Anna and Ms. Florence Nightingale.

Ms. Ketaki Tribhuwan, briefed about esteemed member on dais and introduced the chief guest. Mr. P. V. S. Shastri (Secretary of MKSSS) felicitated Mr. M.A. Sayeed.
