


- a. Ms. Shital More is on leave from 3<sup>rd</sup> may 2018 to 19<sup>th</sup> May 2018 for her marriage.

The meeting of regarding soft skills that took place on 24.09.2019 was briefed to the LMC. The principal informed that:


1. For final year students the soft skills lectures will be arranged in 2020 after their theory final examination. Student will be sent for 4-5 days of full day lectures to skill development.
