Agreement dt. 17/10/2001

On 29th Dec, 1999 Maharshi Karve Stree Shikshan Samstha above mentioned had entered into an Agreement with Jnana Prabodhini Medical Trust, Pune 30, for running of Samstha's Institute of Nursing education at it's Karvenagar campus.

Both the above- mentioned samsthas are of the opinion that the agreement has to be revised and some changes are to be made.

Therefore, the agreement dated 29th Dec. 1999 is being cancelled by both the parties.

The revised terms will be effective from the date of the original agreement i.e. on 29th dec. 1999.


In the month of August 2000, Maharshi Karve Stree Shikshan Samstha started General Nursing And Midwifery three year course under it's branch Institute of Nursing education which is affiliated to Maharashtra Nursing Council and Indian Nursing Council.

Institute of Nursing Education is the activity of Maharshi Karve Stree Shikshan Samstha and Jnana Prabodhini Medical trust will help Maharshi Karve Stree Shikshan Samstha to run the institute in the manner, stated in this agreement as they will get trained nurses to fulfill their requirement of hospitals.



The agreement is prepared under mutual understanding of both Samsthas. It specifies clearly the work participation, financial strategy and administrative part of both the samsthas.

8. Maharshi Karve Stree Shikshan Samstha may divert the surplus amount [after satisfying the need of Institute of Nursing Education] to any other branch of Samstha from the Institute of Nursing Education.
9. The amount incurred on the Library books and Periodicals will be shared equally by both the Samsthas every year.
10. The donation received for establishment and development of Institute of Nursing Education will be kept aside by Maharshi Karve Stree Shikshan Samstha in the name of its account of Institute of Nursing Education. All the collected donations will be utilized for Institute of Nursing Education only.
11. The available medical facilities will be provided free of cost by Jnana Prabodhini Medical Trust to staff and students of Institute of Nursing Education. If medicines and instruments are required from outside they should be arranged personally. Jnana Prabodhini Medical Trust will provide free annual medical check-up for students and staff as per Maharashtra Nursing Council requirement
12. In future if the Institute dissolves, the property and the deposits arranged by Maharshi Karve Stree Shikshan Samstha and Jnana Prabodhini Medical Trust will belong to them and the equipments etc. provided by Jnana Prabodhini Medical Trust will be handed over to them.
13. A token amount of Rs.5,000/- p.a. will be paid to Jnana Prabodhini Medical Trust by Maharshi Karve Stree Shikshan Samstha towards the agreement.
14. If breach of contract occurs while running the Institute of Nursing Education it will be referred to mutually agreed arbitrator under Arbitration Act.
15. Managing Committee of Maharshi Karve Stree Shikshan Samstha agreed on the above mentioned terms and has authorized it's Chairperson and Secretary to sign the agreement. Jnana Prabodhini Medical Trust has authorized its managing trustee to enter into the agreement and sign the agreement.

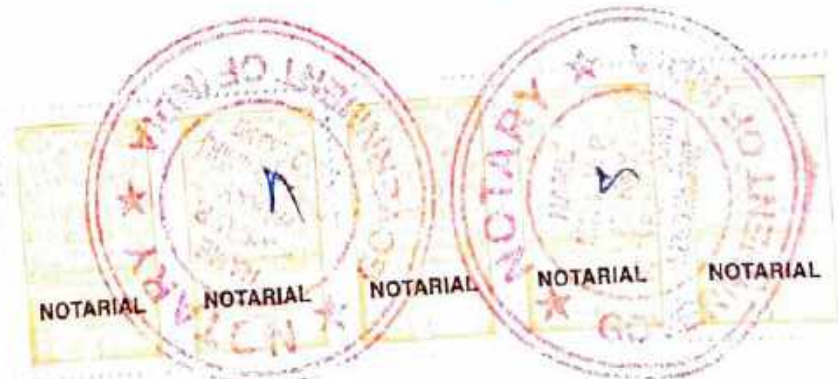

MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (MOU) is executed on this 10th day of February 2014 between:
Khushboo Charitable Trust, a public charitable trust registered under the Bombay Public trust act, 1950, bearing registration number E-5439/Pune and having its registered address at F.P.NO. 25/A1, Survey No 222/1, West Avenue, Kalyani Nagar, Pune 411006, Maharashtra, India (hereinafter referred to as "Khushboo")

And

Smt. Bakul Tambat Institute of Nursing Education, an Educational Institute formed by Maharshi Karve Stree Shikshan Samstha, a Trust bearing registration number F-51, located at Karvenagar, Pune - 411052 (hereinafter referred to as 'Institute')

Whereas,

- 1) The Institute was founded with the objective of working towards upliftment, emancipation and education of women belonging to the economically weaker sections of the society.
- 2) The Institute is approved by the Indian Nursing Council, Delhi and the Maharashtra Nursing Council.
- 3) The Institute runs various diploma, bachelor and other courses for women.
- 4) Khushboo is a public charitable trust founded primarily to promote education and educational activities without profit motive.
- 5) Khushboo intends to provide financial support as sponsorship to the extent and in the manner as agreed in this MoU ('the objective').

Now therefore, the parties enter into this Memorandum of Understanding to lay down the mutual covenants and obligations with respect to the objective.

1. Extent and purpose of Financial aid:

- a) Khushboo will provide sponsorship to 15 students per year of the Institute as per the terms of this MoU.
- b) The sponsorship provided by Khushboo shall vary based on the duration of each course. The details regarding the courses are mentioned under Annexure 1 to this MoU.
- c) The sponsorship to the students will be allotted based on them clearing all subjects in the examinations. The sponsorship shall stand discontinued in case the student does not clear the examinations.
- d) The sponsorship amount shall be decided by Khushboo based on the economic necessity and background of each student which will be assessed and reviewed during home visits conducted by Khushboo.
- e) Following selection procedure will be followed by Khushboo for the purposes of determining sponsorship amount for each of the 15 students:
 - i) Institute will provide a list of students who wish to apply for the sponsorship along with filled forms of scholarship.

- ii) Each student will be interviewed separately.
 - iii) Home visits shall be conducted for each such student.
 - iv) Scholarship amount will be decided by the trustees of Khushboo.
- f) The selection criteria for the sponsorship for Khushboo will be as below:
- i) The student should get minimum 55% aggregate percentage in Class X and Class XII board examinations, and
 - ii) The total annual income of the student's family should be less than 2 lacs p.a.
- g) The sponsorship under this MoU shall be provided either in full or in part only for the tuition fee of the students. Hostel fee or any other expenses will not be covered under the sponsorship amount provided under this MoU.
- h) Once assessment is done for each student, Khushboo will provide the sponsorship as per the course selected by the student and the cheque for the sponsorship amount shall be drawn in the name of Institute.

2. Obligations of each party:

2.1 Obligations of the Institute:

- a) To collect required documents from each student and share with Khushboo as and when needed.
- b) To give list of those students every year to Khushboo, who have cleared their respective examinations.
- c) The Institute shall provide the below list of documents to Khushboo along with each sponsorship application form:
 - i. Scholarship form A
 - ii. S.S.C. statement of Marks
 - iii. Class XI statement of Marks
 - iv. H.S.C. statement of Marks
 - v. CET/ NEET Result
 - vi. School leaving Certificate
 - vii. Ration Card
 - viii. Cast Certificate, if any
 - ix. Income Certificate
 - x. Bank passbook Photostat
 - xi. Mark sheets of every year in respective course.
- d) Utilize the sponsorship amounts for the purpose mentioned above.
- e) Maintain proper records of the utilization of the sponsorship amounts and make the records available to authorized representatives of Khushboo on demand

2.2 Obligations of Khushboo:

- a) To provide sponsorship amounts in time as agreed.
- b) Monitor and evaluate the application of the sponsorship amounts from time to time.
- c) Extend the duration and amount of the sponsorship considering the merit of the same.

3. Term and Termination of the MOU:

3.1 This MoU shall stand valid unless terminated by either party.

3.2 Khushboo may terminate the MoU at any time by serving a written notice to Institute if the objectives of the MoU are not duly achieved. In the event of such termination, Khushboo shall be released of its obligations mentioned in this MoU.

3.3 Institute may terminate this MoU in the event of a breach of obligations by Khushboo and if such breach is not cured by Khushboo within thirty (30) days of receiving notice of the breach from Institute.





4. Amendment to MoU:

The terms of this MoU may be changed/alterd/replaced by executing a written amendment to be signed by both parties.

5. Governing Law:

This MoU shall be governed by and construed in accordance with the laws of the India and shall be subject to arbitration in Pune.

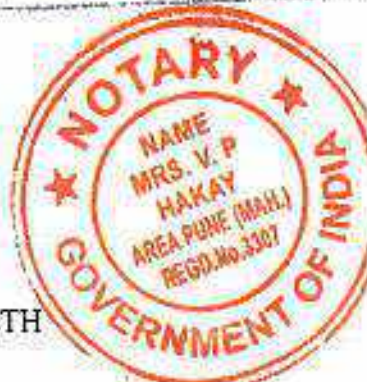

RECITALS

WHEREAS, the Parties agree and understand that coordinational relations exist between MKSSS Anudanit Primary Ashram School, Kamsheth Tal. Maval. Dist. Pune and MKSSS BTINE Karvenagar, Pune-411052

WHEREAS the Parties have discussed mutual goals regarding academic opportunities for their students and Faculty: and

WHEREAS the parties desire to conceive and establish a charter of possible collaborations for the benefit of students and Faculty members of their respective educational and research institutions: and

WHEREAS, the Parties agree to promote joint Education, Research and Development activities of Mutual interests in accordance with their respective needs and objectives.

NOW, THEREFORE, the Parties enter in to this Memorandum of Understanding (MOU), in order to memorialize fundamental concepts regarding the Collaborations.

C. Both institutes shall identify the opportunities of Students' exchange at all levels (Bachelors, Masters and Research) with credit transfer in terms of coursework, project work, dissertation and internships.

Eg- The Parties will explore possibility of recommending students and Faculty for undertaking coursework, Project work, and research work, internship for semester's duration or a year. The recommended students and Faculty shall be selected through well-laid process, on the basis of merit and other non-discriminatory criteria. Each institute shall review the recommendations and consider offering the scholarship/fellowship to eligible projects. A separate agreement can be entered in to, in respect of such exchange programmes.

D. Institute can appoint representative to manage and oversee the activities contemplated under MOU. The representative of the parties can meet as and when.

- E. Each University/ Institute can appoint representatives to manage and oversee the activities contemplated under MOU. The representative of parties can meet as and when necessary to review progress and the implementation of activities related to areas of collaboration, define new ideas etc.

ARTICLE III: Undertaking of the Parties

- A. The Parties understand and agree that they are making a significant commitment to these collaborative effort. Accordingly, the parties to agree to expand their best efforts on the design, implementation and successful continuation of the program.

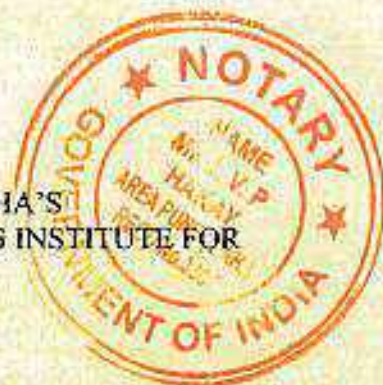

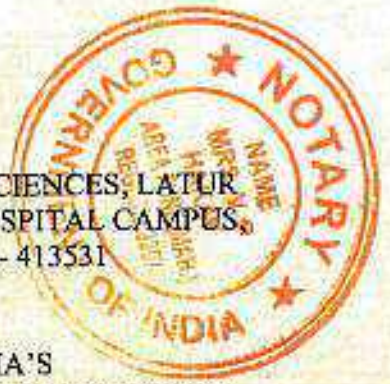

HEREINAFTER referred as "**Dr DYPCON**" (Which expression shall unless it be repugnant to the context or meaning thereof shall mean and include their trustees, heirs, successors, legal representatives, permitted assigns, etc.).

.... **SECOND PARTY**

BACKGROUND

- (A) **MKSSS BTINE** is located in Pune, having its office at MKSSS Campus, Karve Nagar, Pune, India was started in the expansive campus of the parent organization in Pune in August 2000. The institute is approved by the Indian Nursing Council, Delhi, the Maharashtra Nursing Council, Mumbai, and Affiliated to Maharashtra University of Health Sciences, Nashik offering Auxillary Nurse and Midwife (ANM-2 years); General Nursing and Midwifery (GNM-3 years), Basic B.Sc. Nursing (4 years Degree Course); Post Basic B.Sc. Nursing (2 years UG Course); M.Sc.(2 years Course); Ph.D.(Nursing)

- (B) **Dr DYPCON is A CONSTITUTENT COLLEGE OF DR. D. Y. PATIL VIDYAPEETH, PUNE (DEEMED TO BE UNIVERSITY), PIMPRI, PUNE** having its campus at Sant Tukaram Nagar, Pimpri Pune 411 018 established in the year 2000. The College is approved by Maharashtra Nursing Council, Mumbai & Indian Nursing Council, New Delhi. The College has International Collaborations with Johns Hopkins University, USA. The college has highly experienced and well-qualified faculty as per the stipulation of Indian Nursing Council, New Delhi. The College offers Programs like Basic B.Sc. Nursing (4 Years UG), Post Basic B.Sc Nursing (2 years UG Course) and M.Sc in Nursing (2 years Course). Ph.D in Nursing and Certificate Course in Critical Care Nursing (6 months).
- (C) The two parties have identified that a stronger relationship between them is mutually beneficial and wish to establish a more formal relationship with each other.
- (D) This MoU provides for the establishment of a general agreement to co-operate in the areas of faculty and student exchange, joint teaching and learning, general cooperation, particularly in the areas of education between MKSSS BTINE and Dr DYPCON.

1. COMMENCEMENT AND DURATION:

This Memorandum of Understanding ("MoU") shall take effect on the date of signing and shall continue for a period of 1 year. The MoU can be renewed based on mutual consent of the parties after verification of the activities developed during its duration.

2. FORCE OF THIS MoU:

- 2.1. The areas of agreement outlined in this MoU are described to facilitate more detailed and specific negotiations between the parties which may lead to the preparation and signing of one or more formal agreements between MKSSS BTINE and **Dr.DYPCON**. Unless specifically noted herein, in particular by designating the clause as binding, this MoU is not intended to be of legal force and effect in any manner whatsoever. This MoU shall not create a legal relationship between the parties. Although a separate agreement / MoU will have to be signed before start of any research, etc. requiring any specific permission and involving legal or financial responsibility.

3. BROAD AREAS FOR COOPERATION:

3.1. MKSSS BTINE and Dr DYPCON will discuss the possibility of cooperation in the following areas:

- (a) Knowledge share through seminars, workshops, summer schools, webinars and other similar initiatives
- (b) Collaboration opportunities for resource persons, international guest etc.
- (c) Faculty exchange
- (d) Student exchange
- (e) Joint programs for double degree and PhD
- (f) Joint research and the development of studies and collaborative research projects. (Only Through separate Agreement)

3.2. Representatives of the Parties may agree to review the operation of this MoU from time to time by forming a committee of members belonging to both the parties.

4. CONSIDERATION / CHARGES:

The signing of this MoU does not entail any financial obligation for the parties and shall be restricted only to non-financial aspects under and beyond this MoU.

5. CONFIDENTIALITY AND PRIVACY:

5.1. MKSSS BTINE and Dr DYPCON recognize that they will come into possession of information which the other considers to be confidential, including Personal Information ("Personal Information" means information and opinions recorded in any form about an individual whose identity is apparent, or can reasonably be ascertained, from the information or opinion). Each of MKSSS BTINE and Dr DYPCON contractually agrees that it shall not, at any time, disclose to any third party, any confidential information of another party without first having obtained the prior written consent of the other party.

5.2. The provisions of this clause are intended to and shall be binding upon the parties upon the signing of this MoU and shall survive the termination or expiry of this MoU.

6. INTELLECTUAL PROPERTY:

- 6.1. "Intellectual Property" means and includes all copyright, all rights in relation to inventions (including patent rights), plant varieties, register and unregistered trademarks, registered and unregistered designs and all other rights resulting from intellectual activity in the scientific, industrial, literary, or artistic fields.
- 6.2. Each party shall retain all rights to existing intellectual property belonging to it and contributed by it ("Background IP") at the commencement of each Research Project arising under this Agreement.
- 6.3. In case the need arises for applying for any IPR it shall be through the Incubation Centre of DPU and the cost for it shall be mutually shared by both the parties.
- 6.4. If any IPR issue emerges as a result of joint research, then a specific IPR addendum will be jointly agreed upon.

7. AMENDMENTS AND SUPPLEMENTARY AGREEMENTS:

- 7.1. The parties may agree to amend this MoU at any time by further memorandum in writing executed by the duly Authorized Officer(s) of each party.

9. PUBLICATION:

The parties have agreed to consult each other for any publication in respect of the any collaborative projects under this MoU. The contributors from Dr DYPCON and MKSSS BTINE will be included as authors or their contribution will be duly acknowledged as per the guidelines for authorship at the time of publication of manuscripts.

Both the parties will jointly bear the publication fee on case to case basis.

10. NOTICES:

11. TERMINATION:

- This MoU is subject to the termination clause wherein either party is unable to fulfil the any agreed commitments, which includes scope of work in fix time duration and committed any working standard and procedure, mentioned.
- Both parties may terminate this Memorandum of Understanding, by giving 30 days prior notice in writing to each other. Upon the expiry of 30 days from the date of notice, as aforesaid, the Memorandum of Understanding shall stand terminated.
- Both parties may terminate this Memorandum of Understanding in case both parties have committed a material breach of terms provided herein.
 - FIRST PARTY or its Staff, Students fails to perform, has made or makes any inaccuracy in, or otherwise materially breaches, any of its obligations, covenants, or representations, and
 - The failure, inaccuracy, or breach continues for a period of Three Business Days after SECOND PARTY delivers notice to FIRST PARTY reasonably detailing the breach.

MEMORANDUM OF AGREEMENT

This Agreement is between Maharshi Karve Stree Shikshan Samstha, Pune, India and "Research Unit – Medical Research in Developing countries UNESCO Chair in Bioethics" University of Applied Sciences and Arts Hannover (UNESCO – HSH), Faculty III Media, Information and Design and Sumati Deshmukh Institute of Foreign Languages (SDIFL)

The two institutions agree to engage in an exchange and cooperation program as follows:

Purpose and Requirements:

The two institutions shall commence cooperation in the following field:

- a. Student exchange program: India - Germany Cultural Exchange Program

The present agreement is not restricted to the field of collaboration mentioned above and could also include other fields or other forms of collaboration as agreed to by both parties.

This will enable students from both institutions to derive increased benefits provided by a change of cultural and educational venue.

Students visiting the host institution for the duration between a week and three months shall be subject to the same rules and regulations that the host institution requires from its own students, and shall also be subject to their home institution's rules and regulations. Exchange students shall also be recipients of all the privileges and rights that are normally accorded to the students of the host institution.

Maharshi Karve Stree Shikshan Samstha shall encourage its own students to acquire a working knowledge of the German language before engaging in an exchange program which requires substantial class attendance in German. HsH shall do the same regarding the English Language for its own students wishing to join cultural exchange program or internship program for a substantial period.

To enable faculty members from both institutions to share information and to engage in collaborative research.

Faculty members wishing to visit the host institution for a semester or a year shall be subject to the rules and regulations of both institutions pertaining to this issue. The host institution shall attempt to assist faculty in securing housing and medical insurance.

Both institutions shall attempt to keep each other abreast of developments that may affect the cooperative programs that the two institutions are engaged in.

Number of Students

Up to 25 students may go to each institute for a period of one week to three months under cultural exchange program. Whilst equivalent numbers may be difficult to achieve, each institution will exercise maximum effort to achieve balance at the end of each third year.

Responsibility of the Institution:

The two institutions shall not be responsible for any charges incurred for rooming, boarding, insurance and travel, as these are responsibilities of the student(s) concerned.

Responsibility of the Student:

Students shall be responsible for their accommodation bookings, personal belongings and all costs related to travel, accommodation, insurance, food and incidental expenses. Students shall be responsible for clearing with their advisors which courses are to be taken at the host institution.

Duration of Agreement:

This Agreement shall be of a 3-year duration commencing 2 March 2016. It may be renewed by mutual consent, thereafter. Should either party wish to terminate this Agreement, notification should be given to the other party one year prior to the proposed date of termination. Termination shall not affect those students or faculty who have been accepted for exchange.

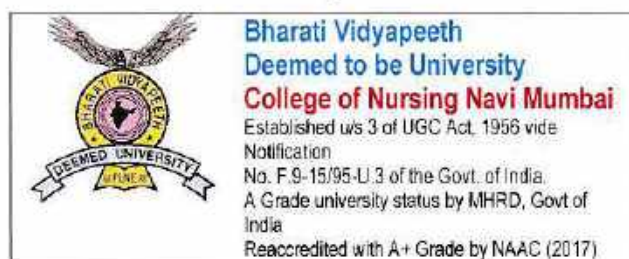
