**Report:**

**MKSSS Smt. Bakul Tambat Institute of Nursing Education** had organized ‘One day basic training programme on Human Rights’ on 27<sup>th</sup> March 2024 sponsored by The National Human Rights Commission, New Delhi. The participants were final year Basic B.Sc. Nursing and third year GNM Nursing students. The program's organizational secretary is Mrs. Ujwala Jadhav, an Assistant Professor of MKSSS BTINE.

On 27<sup>th</sup> March 2024, at 8:00 a.m., we began the training program by registering each participant and distributing the training kit. There were a total of 100 participants, which included MKSSS BTINE final-year GNM and Basic B.Sc. Nursing students.

Breakfast was scheduled to be served from 8:00 am to 9:00 am at Sampada Canteen.

**Link for questionnaire** for pretest was sent to participant’s mobile and instructed to complete it before the inauguration.

At 09:00 a.m., we had the inaugural ceremony with Dr. Kranti Deshmukh, Principal (LAW) at Shankarrao Chavan Law College, Pune, as the chief guest. Dr. Meena Ganapathy, Principal of MKSSS BTINE, Mrs. Ujwala Jadhav, the organizing secretary, and Ms. Smita Lisham, the organizing member, were also present on the dais.

A prayer song followed by welcome song was performed by our students. Ms. Mayuri Nijampurkar, M.Sc. nursing student, started the programme with briefing about the training programme and requested all the respected member on the dais to pay homage to Anna and Baya Karve.



Ms. Mayuri Nijampurkar, briefed about esteemed member on dais and introduced the chief guest **Dr. Kranti Deshmukh**. Dr. Meena Ganapathy (Principal of MKSSS BTINE)) felicitated Dr. Kranti Deshmukh. During her welcome speech, Dr. Meena Ganapathy discussed the significance of human rights and how they relate to nursing. In addition, Dr. Kranti Deshmukh provided the program's keynote address, emphasizing the importance of human rights and our civic responsibilities. A vote of gratitude was given by Ms. Mayuri Nijampurkar to conclude the inauguration session.

### **Session I-Introduction to human rights:**

**Dr. Kranti Deshmukh**, Principal (LAW) at Shankarrao Chavan Law College, Pune has started her session at 10:00 a.m. She highlighted on constitutional provisions made as per Indian law system, Universal Declaration on Human Rights, 1948 and International Covenants regarding Human Rights. After her session, the topic was open for discussion, students had asked thought provoking questions and resource person had responded with appropriate answer for them.

After the first session there was tea break for 15 minutes.

### **Session II- Human Rights Institutions in India:**

At 11:45 a.m. **Dr. Revati Naik**, Asst. Professor and secretary of center for Advanced legal and training working in Shankarrao Chavan Law colleges, Pune has started her session on Human Rights Institutions in India. She provided knowledge on protection of Human rights Act 1993, Composition and functioning of NHRC/SHRCs and other national/state commissions. She shared her experience and different case studies with the students. After the session, discussed and clarify all the question arises by the participants.

**After that there was lunch break for 30 minutes.**

### **Session III - Rights of Women and Children:**

After lunch at 02:00 p.m. we started the session-III on **Rights of Women and Children** by **Mrs. Nalini Ambad**, Associate Professor, MMM's Shankarrao Chavan Law College, Pune. She discussed about UN Convention on the elimination of all forms of discrimination against women, 1979 and its optional protocols and also UN convention on the Rights of the Child, 1989 and its optional protocols. She gave a broad spectrum regarding the safety of the women and child in today's era. She shared many examples and her experiences on the same. She also guided the students how we can help others and self-protection.

After this session there was tea break for 15 minutes.

#### **Section IV - Rights of other vulnerable groups:**

At 03:45 p.m. **Adv. Parikrama Khot**, Lawyer and Legal Consultant working at Shivajinagar High court, Pune had started the session-IV on **Rights of other vulnerable groups**. In this session she covered about Bonded Labour Issues & the Bonded Labour System (Abolition) Act, 1976, Child Labour Issues & Child Labour (Prohibition and Regulation) Act, 1986, SC/ST issues & Scheduled Caste and Scheduled Tribe (Prevention of Atrocities) Act, 1989, Civil Liberties Act, 1988 & the Forest Rights Act, 2006.in detail.

**Valedictory ceremony** was started in presence of **Adv. Parikrama Khot**, Dr. Meena Ganapathy (Principal, MKSSS BTINE), Mrs. Ujwala Jadhav (Asst. Professor, MKSSS BTINE) and Ms. Smita Lisham (Asst. Professor MKSSS BTINE). Mrs. Ujwala Jadhav, gave the vote of thanks to everyone who helped to make the training session a successful event.
