## **5. Academic-related issues:**

### **i. Course evaluation and action taken report:**

Principal Dr. Meena Ganapathy informed LMC that stakeholders, parents, and students are satisfied with the college's infrastructure and facilities.

**a) Issue:** Students are asking for a bus facility for all postings. Sometimes, the postings overlap, causing a problem.

**Solution:** Principal Dr. Meena Ganapathy said that the proposal for the bus is in process.

**b) Issue:** Day scholar students were having a problem sitting on the floor while having lunch.

**Solution:** Principal Dr. Meena Ganapathy informed LMC that we have arranged 13 tables and 80 chairs and placed them in the front area of the Suswad canteen. Students are instructed to use these tables and chairs during their lunch break and return them to their original position after lunch.

**c) Issue:** Students are asking for variety in breakfast and lunch, hot water, and a study room in the hostel. Students were also complaining about the bugs, cockroaches, and lack of cleanliness in the hostel, especially the bathrooms and toilets.

**Solution:** Principal Dr. Meena Ganapathy informed that we have conducted a meeting with the hostel-in-charge, Smt. Shah, and discussed the above points with her. She promised that they would work on the above suggestions.
